

VILLAGE OF ARCANUM  
WATER AND LIGHT DEPARTMENT  
UTILITY SERVICE AGREEMENT

This agreement made and entered into by and between the Village of Arcanum, Ohio and the Consumer identified below. In consideration of the agreements, herein set forth, the Village, and the Consumer and/or residents taking electric and or water service at the premises listed below, does hereby mutually agree as follows:

THE CONSUMER NAMED ON THIS AGREEMENT MUST RESIDE AT NOTED PROPERTY, UTILITY SERVICES CAN BE TERMINATED AT ANY TIME IF CONSUMER MOVES FROM PROPERTY BUT CONTINUES UTILITIES IN THEIR NAME, WHILE ANOTHER RESIDENT LIVES AT PROPERTY.

**ARTICLE 1:**

The Village of Arcanum will supply electric and or water service from its utility system to the consumer's premises located at the address identified below.

**ARTICLE 2:**

For the electric and or water service furnished under this contract, **the consumer and/or residents, agrees to pay the Village monthly**, for electric and or water service supplied, in accordance with the Village's Rate Schedule, as it may be amended from time to time.

**ARTICLE 3:**

The Village of Arcanum will furnish the meter and other equipment necessary to bring electric and or water service to the Consumer, which shall remain the property of the Village and the Village shall be permitted to remove the same at the termination of this agreement.

**ARTICLE 4:**

**The Consumer agrees that the Village shall have convenient and practical access, location and right-of-way** to and upon the Consumer's property as may be necessary to properly furnish and maintain the electrical and or water equipment required to serve the Consumer and as may be necessary to monitor the Consumer's use of electricity and or water.

**ARTICLE 5:**

The Village shall not be liable to the Consumer for any loss, injury or damage resulting from the Consumer's use of this electric and or water service, the Consumer's connection to Village electric and or water service, interruption of service, consequential or incidental damages, and any cause reasonably beyond the Village's control.

**ARTICLE 6:**

This agreement shall be in force beginning on \_\_\_\_\_ and shall continue in force thereafter until cancelled by not less than seventy-two (72) hour notice by either party. The Consumer shall not contract with any other electric and or water supplier for electric and or water service to be supplied during the term of this agreement
